All elections are important. This election is no different. On or before November 5, you will be asked to select who will become the President (and Vice President), who will serve as your U.S. Senator for the next 6 years, two individuals who will serve on our Ohio Supreme Court for the next 6 years and one Associate Justice to finish an unexpired term for two years, who will serve as your Ohio Senate member for the next 4 years for 16 open seats and 1 to fill the last two years of an unexpired term, all 99 members of the Ohio House of Representatives, and a host of other important local issues throughout the state.

The “2024 Election Guide” was compiled to help provide you with guidance on which candidates have been endorsed by major trade associations and business groups, or have been favorably recognized by an organization for the November 5 general election. Some candidates can claim to be pro-business, but only those individuals with a good track record or who have been thoroughly screened have earned an endorsement by state and national associations that represent the business community.

All of the associations and organizations mentioned above choose to endorse or not to endorse for various reasons. You will note below that there are candidates whom all associations have endorsed, some whom most have endorsed, and others whom these associations simply agree to disagree. Please contact the respective association if you would like to know more about how to become a member and their endorsement process.

**Monday, October 7:** Voter Registration or Address Update. You must register or update your voter registration no later than 30 days prior to an election. [Click here](#) to register or update your address.

**Tuesday, October 8:** Absentee and In-Person Early Voting Begins (through Monday, November 2). Don't know where to go to vote in person? [Contact your local county board of elections](#). Mailed ballots must be postmarked by November 4.

**Tuesday, October 29:** [Applications for absentee ballots](#) to be mailed for the November 5 general election must be received by boards of elections by noon (3 days prior to the general election). Absentee ballots returned by U.S. mail must be postmarked no later than November 4 and received by boards of elections by November 15 (10 days after the general election) to be counted.

**Tuesday, November 5: Election Day!** Deadline to drop-off your ballot in person. Polls open from 6:30 a.m. to 7:30 p.m. Absentee ballots, either returned in person or via a method other than U.S. mail, must be received by the boards of election by close of polls.



## Election Day – Voting In-Person

The polls are open from 6:30 a.m. to 7:30 p.m. on Election Day. You will need to take one of the following forms of identification with you in order to vote.

- + Ohio driver's license
- + State of Ohio ID card
- + Interim ID form issued by the Ohio BMV
- + U.S. passport
- + U.S. passport card
- + U.S. Military ID card
- + Ohio National Guard ID card
- + U.S. Department of Veterans Affairs ID card

All photo IDs must have the following:

- + An expiration date that has not passed
- + A photograph of the voter
- + The voter's name, which must substantially conform to the voter's name as it appears on the Poll List or in the Poll Book

**NOTICE:** An unexpired Ohio Driver License, State ID Card, or Interim Documentation with your former address IS an ACCEPTABLE form of ID when your current address is in the Poll Book.

## Voting By Mail


If you were previously registered to vote in Ohio you may have already received your vote by mail application. If so, fill it out and return it as soon as possible to receive your ballot by mail starting October 8. If you did not receive it or cannot find it, follow the following steps to request your ballot to vote by mail.

- + Complete the application and mail it to your board of elections
- + Once you receive your ballot, mark all your selections and return it in the ID envelope as instructed. All ballots must be postmarked by Tuesday, October 29 or received at your local board of elections by 7:30 p.m. on Tuesday, November 5, 2024.

## Are Employers Obligated to Give Employees Time Off to Vote?

Since 1953, Ohio law has stated, "no employer, his officer or agent, shall discharge or threaten to discharge an elector for taking a reasonable amount of time to vote on Election Day." The fine for violating this law ranges from \$50 to \$500. For a list of other state employee voting laws [click here](#). Therefore, employers should encourage, not discourage, employees from voting. But, it's not just about voting. It's about making sure electors are educated voters and take the time to vote on every candidate and issue on the ballot. Voter turnout in Ohio is highest during presidential election years.



Historically, 70-75% of registered voters turn out to vote for president and vice president. But, the "drop-off" rate for other candidates and issues down the ballot can be significant, affecting state and local races, as well as ballot initiatives and issues. Therefore, while the 2024 Election Guide is not exhaustive resource, it can serve as a reminder to vote for your employees or members and provide them with the tools they need to be an educated voter on all the candidates and issues for the November 2024 ballot.




## Balance of Power

Republicans + Democrats are trying to pick up as many seats as possible to tip the balance of power at the national and state level. Here is a quick breakdown of how many seats each party needs to pick up in order to take control of their respective chamber.

## Statewide Ballot Issue

Voters statewide will get to decide the outcome of a proposed Amendments to the Ohio Constitution to reform the state's legislative redistricting process.

### Issue 1

#### Redistricting Amendment

State Issue 1 proposes a constitutional amendment to reform the state's redistricting process. It would establish a 15-member, non-partisan Ohio Citizens Redistricting Commission responsible for drawing state legislative and congressional district maps.

This commission would be composed of five Republicans, five Democrats, and five individuals who are independents or members of other political parties and would be appointed by a screening panel of four retired judges (two Republicans and two Democrats), excluding politicians, party officials, and lobbyists, to review and screen applicants who are interested in serving as members of the commission. The ballot initiative would require the commission's actions and deliberations to be conducted in public meetings. Actions would require the affirmative vote of at least nine (of 15) commissioners, including at least two Republicans, two Democrats, and two independents.

The stated goal of the ballot measure, according to Citizens Not Politicians, is to reduce gerrymandering and create fairer, more transparent district boundaries. If passed, the new system would replace the Ohio Redistricting Commission, established in 2015 for state legislative districts, and the process established for congressional districts in 2018, starting in 2026 the proposed new commission must adopt final redistricting plans by July 15th of every year ending in one (2031, 2041, and so on).
